## How to Become a Ham...in 1955



A Philco Cathedral

In the mid-to late 1940s my mother bought a Philco Cathedral radio. It was a fascinating thing to a kid. We had no TV back then. When school let out I could not wait to get home to listen to the Lone Ranger, The Shadow, Green Hornet and so on.

As I got older I would tinker with radios. Once I put up a wire antenna and attached it to an AC/DC radio and hooked a ground wire to the chassis: wrong thing to do! Big bang, smoke and a putrid smell. That could have been the end of my tinkering if my parents had found out, but I continued to tinker and found if I turned the screws on the tuning capacitor it would receive signals other than broadcast. I began hearing W4YPZ who was talking to others I could not hear, and that led to my interest in ham radio. I purchased a book at the newsstand titled <a href="How to Become a Radio Amateur">How to Become a Radio Amateur</a> put out by the ARRL. In 1955 I was a 17-year-old sophomore in high school who knew it all. Despite that I managed to learn how send and receive Morse code. I contacted the FCC and requested the exam for a Novice license. It was sent to me with instructions threatening a large fine and jail time if I opened it. The deal was to take it to a licensed amateur radio operator holding a General class license and he/she would open it and administer the exam. I made arrangements for my dad to take me to Furman James' (W4YPZ) home where he gave me the 5 wpm code test. I passed the code test. He opened the sealed package, and I answered the 25 questions and mailed the test to the FCC. I soon received the call sign KN4KAY that was good for one year and not renewable.

My first rig was a WWII Surplus ARC-5 Command receiver that covered 3 to 6 MHz and a breadboard 6AG7 transmitter running a couple of watts. I built it from my How to Become a Radio Amateur book. I have misplaced my log over the years, but the FCC required that you log every contact with time, date, frequency, mode and call signs, which I did. I have to say that when the first station answered my CQ on CW I was as nervous as a hen guarding her biddies in a pit full of alligators. I wanted more power, and I soon built a transmitter with a 6146 tube running around 60 watts. As a Novice, you were allowed to run 75 watts input power. Using Ohms law (P=EI); a milliamp meter in series with the RF choke, and measuring the current draw to the 6146 tube using approximately 600 volts DC would give me the input power. I still have some of the QSL cards from back then. I probably had more fun that first year working CW as a Novice than any time since.

In 1956 I was able to upgrade to a General class license and drop the N from my call. The FCC office was located in VA, but several times a year they would come to Winston Salem and give tests for all amateur and commercial radio licenses. They had a tape recorder, which was set up in the middle of the room. They gave everyone a pencil and sheet of paper; the tape recorder was started and ran about 5 minutes at 13 words per minute. The text was a simulated amateur QSO. The papers were then collected and graded. If you passed, you were invited to send CW at 13 wpm from text they provided. If you passed the sending test, you were finally given the written test, which consisted of 100 questions. No multiple choices here, you were asked to draw several schematic diagrams of transmitter circuits with components and values of resistance and capacitance. The circuits were of oscillators, class B modulators, tank circuits, etc. Some of the questions related to operating, frequencies, and rules and regulations. I failed the first time but passed on the next session.

Once you had the General class, it opened up a whole new world of frequencies and modes of operation such as AM, Teletype and that new mode called SSB but there were still limits on your area of operation within the bands. You could only operate on the entire band if you had the Extra Class license. That was a challenge, with a 20 wpm code test and a much more technical written test consisting of just 50 questions. It was probably 15 years before I passed the Extra, but in the meantime they came out with the Advanced class license which required the 13 wpm code speed and 50 multiple choice set of questions that were less technical and more about operating rules and regulations. I never took the Advanced test, but went for the Extra, and after two tries I got the Extra class license

and all the privileges that went with it.

Amateur Radio has come a long way since then, and drastic changes have taken place. CW is no longer required, and while I personally think that was a huge mistake, it has opened up a hobby to a lot of folks who would not be hams today if changes had not taken place, and that's a good thing. On the technical side, we now have transceivers that weigh less than five pounds that outperform those 50 lb. receivers and 300 lb. rack mount transmitters you see showing up at hamfests year after year.

It seems to me that Morse code is on the upswing, and I would urge you to try it. It takes a little effort and is sort of like learning to type by touch. It does open up a new mode of communications, and I am sure you would be as excited and nervous on your first CQ as I was 59 years ago.

#### Some other thoughts:

Now I'll switch hats and invite every member of W4BFB to join the Hamfest Committee. It doesn't matter if you have been a member for 50 years or 5 days, we need your help and input. It is not hard and no one will twist your arm to be on a committee. Just sitting in on a meeting and listening to the Committee Chairmen report on the progress of getting programs, forums, dealer commitment, postage, flyers, tables or whatever; there will always be problems to solve and questions to be answered, and you might just have a great idea no one has thought of. You could be the one that could get the Chief of the FCC to visit our hamfest, or some other idea that could appeal to the masses and create a great turnout. The profits from past hamfests allowed this club to put up a network of repeaters, buy radios and antennas for our club station, antennas, trailers, and a camper for field day and emergencies, Discovery Place and donations to the Red Cross, MS and many others. We really do need your input and help.

And last but not least John, NV4A, needs some articles for the newsletter. Most any subject will do, and John will do the spell check and editing for you. Anybody else who wants to share their early ham experiences? ....or even have some really exotic QSL cards you'd like to scan and send to John?




## Request for Articles ...again
