






MARS in Motion

Another GeekFest in the Log



The thirteenth annual CPCC GeekFest was the eleventh year that W4BFB was there. We were represented by Jerry N2PSA, Alfred KC2GZI, Bill W4WNT, Jim W4JBP, Charles KK4HOK, and John

WB2NHQ. It was also good to have Richard K4KRW visit, bringing his new mini QRP (Arduino controlled) kit which looked right at home on our GeekFest table.

We renewed old acquaintances, met lots of "new geeks," visited with other technology exhibitors, and described ham radio to lots of visitors. Along with CPCC students, faculty, and staff, there were also hundreds of Charlotte Mecklenburg high school students visiting. With the theme "When All Else Fails," we could show visitors that we can do comms without infrastructure. We had our HF Go-Box and our VHF GoBox on the air, using PSK-31 and packet, with G5RV and EDZepp antennas hung

from the roof over the adjacent patio. Using our 2-meter packet connection with either our NCCLT or SPENCE nodes to the RMS connection in the clubroom, we could send an email to a visitor as he watched the lights blink and heard the radio chirp.

Greetings from Karl W4CHX, your ARRL NC Section Manager!

REMINDER! MOMENTUM BUILDING TO URGE SENATE PASSAGE OF THE AMATEUR RADIO PARITY ACT – The response to ARRL's call to action urging the support of US Senators for the Amateur Radio Parity Act, H.R. 1301, has been gratifying — although the campaign continues. Presently, the US Senate has recessed without acting upon the Amateur Radio Parity Act.

But, that does not mean ARRL Members should take a break – your help is still needed! As of October 20th, more than 62,000 letters have been sent to Capitol Hill, including 1,036 letters that have been delivered to each office of our US Senators – Senators Richard Burr and Thom Tillis. If you have not sent letters, please use the Rally Congress tool to contact Senators Burr and Tillis and request their support of HR 1301 by voting favorably for the Bill. RECENT SUCCESS STORIES ON ANTENNA SUPPORT STRUCTURE PERMITS – While we wait for projected passage and enactment of HR 1301 Amateur Radio Parity Act by the US Senate, there have been two recent success stories where NC Hams living in areas not covered by homeowner covenants, conditions, and restrictions (CCRs) overcame antenna support structure restrictions through the use of existing federal rules and State statutes.

Larry J. Ford, K4AEC, ARRL Volunteer Counsel, Roanoke Division, reports a recent case which resulted in amateur radio operators in Caldwell County now being able to erect antenna support structures, such as towers, in single-family residential zoning districts. Previously, the County Attorney for Caldwell County had issued a ruling that stated zoning permits could not be issued for amateur radio towers on property zoned single-family residential, thereby relegating amateur towers to commercial or other zoning districts. Of course, the vast majority of hams want and need their towers as accessory structures to their homes, and the County Attorney's ruling prevented that in most cases.

After learning of the ruling, Larry K4AEC contacted the County Attorney and over the course of several weeks, provided the County Attorney with the legal authority, including Federal case law, Regulations, FCC PRB-1, and the North Carolina Statute on amateur radio towers, all of which require a local government to "reasonably accommodate" amateur radio antennas support structures including towers. After these communications, the County Attorney reversed his ruling, and the ham whose application was denied received his zoning permit to construct his tower.

Larry K4AEC also reports this was the second similar case recently in North Carolina, as he was involved with a similar matter in the City of High Point a couple of years ago, which resulted in the City of High Point amending its Zoning Ordinance to allow towers.

Larry K4AEC stated: "From my experience, a lot of City and County Attorneys, as well as Zoning Administration officials, are totally unaware of the Federal law and state statutes which prevent local governments from summarily denying or prohibiting amateur radio towers. In many cases, I can talk to the City or County attorney, provide the legal authority they are unfamiliar with, and achieve a positive outcome. I encourage ARRL Members to contact me or one of the other Volunteer Counsels (all of whom are licensed hams) if a tower application has been denied so we can attempt to rectify the situation on an informal basis (there is no charge to an ARRL Member for an initial consultation). However, there are cases where the local government is so entrenched in its position that the only solution is litigation, as we experienced a few years ago in the Charlotte tower case." CURRENT RULES HOLDING HAMS BACK FROM ADOPTING STATE-OF-THE-ART TECHNOLOGY, ARRL SAYS (DEADLINE, 11/10) – In comments filed on October 12 with the FCC, ARRL reiterated its case that the FCC should change the Part 97 rules both to delete the symbol rate limits in Section 97.307(f) and replace them with a maximum bandwidth for data emissions of 2.8 kHz on amateur frequencies below 29.7 MHz. In a July Notice of Proposed Rule Making (NPRM) in WT Docket 16-239, the FCC proposed to eliminate the current baud rate limitations for data emissions, consistent with

ARRL's Petition, but it declined to propose a bandwidth limitation for data emissions in the MF and HF bands to replace the baud rate limitations. The deadline to file comments in the proceeding — i.e., comments on comments already filed — is November 10. 

Program: October 25th MARS History

Mary Hunt N4MH kicked off our program by telling everyone that our club was started on

March 25, 1949, with thirteen members. She gave an "overview" of the Buck Wortman's article "A Bit of MARS History." Amateur





radio didn't take off until WWII. [http://www.w4bfb.org/archive_marshistory.php]

Cliff Greene WB4NHQ shared his history starting in 1968, when he drove to Charlotte from Waxhaw to take his first novice exam in the Red Cross Building. He remembered lots of rides being offered across counties by hams. In 1969, the ham community covered the expenses for both his friend Thomas and him to take their General license exams in Atlanta. Cliff shared many heartwarming stories about his ham radio family.

Mary N4MH got her ham license in 1960 in Johnson, Tennessee. The VE program wasn't established until 1980. She joined MARS in 1984.

John White W2NHQ -

In 1977, John lived in New York. At that time, you had to be able to send and receive 5 WPM Morse Code before you could take the test. 1979 – John came to Charlotte and was looking forward to take his Technician test at the Charlotte Hamfest. In the middle 70s, a bunch of guys got together and formed W4CQ. He went to his first ham club meeting at the Red Cross Building. They met at Duke Power and then the Charlotte Memorial Hospital conference room. We had one of the first packet nodes.

The internet wasn't around then nor smartphones, but you'd get your QST Magazine! You'd decide what you wanted to buy and then would start saving your money for Charlotte Hamfest in March!

During the late 80s and early 90s, John was the Public Service Chair with a clipboard trying to get sign-ups. Each year, they would visit the pediatric ward of the Charlotte Memorial Hospital. A young woman named Lisa would dress up as an elf and carry a ham radio. Then she'd go to the pediatric ward of Charlotte Memorial Hospital to talk to the kids. They'd give the kids water bottles with a picture of Santa on it with the inscription, "I talked to Santa on ham radio." Doug played Santa on the air, asking the kids want they'd want to say to Santa.

In 1989, we had a special event at the Discovery Place to announce the addition of a ham radio station there.

Bill Turner W4WNT – Bill has been a MARS member since 1991. What amazed him is how well everyone gets along in the Charlotte ham community.





Andy Hawkins K4GKK showed his MARS membership certificate dated 1985, and **John Covington W4CC**, a MARS member since 1988, wrapped up our Club History program via a video presentation.
