MARS 2007 Holiday Party



McGuire Nuclear Exercise

It was Tuesday October 16. I had known about what was coming for a few weeks. It wasn't the "real thing big one", but the McGuire Nuclear Exercise was upon us. The challenge was: how do we put together an adequate response to a communication request, on a typical work day? Of course, we can do it by calling on a dedicated group who will volunteer their time and show our community that ARES can be relied upon.



The Emergency Operation Center was activated with many agencies represented: Meck Emergency Management, CMPD, CFD, MEDIC, Carolinas Hospital System, Presbyterian Hospital, Meck Sheriff department, DSS, Charlotte-Meck Schools, Salvation Army, Red Cross, and FEMA. The list of participating agencies is long and includes most of whom we consider to be our Meck ARES served agencies. The EOC was full of technology; laptops on the LAN for everyone and large status screens projected on the walls. Everyone there had telephone service provided via VOIP (voice over IP). How would you like to be that LAN administrator? Now you can see where we fit, with our backup emergency communications not depending on any of that technology.

After a Monday of preparation and checking of our equipment, Randy KE4JXF spent his Tuesday with MEDIC. Jim N5RTG put two new stations on the air at Carolinas Medical Main campus, the first we had heard these new stations participate in a county event. Keith KI4SDO was at the Red Cross Disaster Center where simulated evacuation shelter preparations were made. Brian KF4VOO and John WB2NHQ were 'kinda busy' at the EOC with packet and voice operations using the bottleneck of a single mag-mount antenna on a roof air duct. Dave KD4ITI was our packet and adjacent county liaison at Discovery Place. George N3BW was HF liaison to the Tarheel Emergency Net, and part of the scenario was transferring command and control to our state Emergency Management. (Have you been reading those FEMA ICS online courses?) Jodie KI4CXO and Dan KG4ENP were our net controls at the Red Cross 'BFB clubroom.

A conservative estimate of around 70 Ham-hours were volunteered in just a few hours of clock time, not counting those other stations who checked in with our 146.94 resource net. It's really comforting to hear that Hams can "be around" when something happens.

Radio waves and simulated nuclear winds don't stop at the county line. During the day we exchanged messages with not only our own served agencies, but also most of our adjacent counties. It was good to hear from Hams in Cabarrus, Stanly, Iredell, Lincoln, and Gaston who were also representing their county EOCs, Fire Departments, etc. About half of our traffic was sent and received using packet radio, the rest by phone.

So finally here, a BIG THANK YOU to all for your time and dedication. Get your batteries charged again though because we'll do this again during the North Carolina Simulated Emergency Test coming real soon on November 3.

Jamboree on the Air

The three of us had all antennas in the air by 11:00 am. That left us an hour to get the radios operational and make other preparations.

We expected to be busy between 1:00 pm and 3:00 pm. My children showed up at about 12:00pm. And, sure enough, our first scouts showed up about 12:30 pm. We had somewhere around 30 scouts show up at our site. The majority of them were with Brownie troops. The rest of them were young Girl Scouts. They were mostly somewhere around the 5th or 6th grade.

We talked with the scouts, leaders and parents about the Amateur Radio Service. They seemed very intrigued with long distance communication over HF. Unfortunately, it wasn't a very good day for us on the lower bands. I talked briefly with a station near Houston, TX. QSB and high noise levels made communication very difficult. JOTA is an international event. Interestingly, one of the first stations we heard on HF was a JOTA station operating out of Prague, Czech Republic.

The children had a great time talking to other scouts on the local repeaters.

We talked to scouts at three or four other locations around the local area. Jeff (KA4WYC) and Jodie (KI4CXO) were running the JOTA session at Camp

Questions included: "How does your radio catch the signal coming from the other radio". One asked "When you hear a signal from a far away station, how do you make sure your reply goes back to that station." So, obviously, a bit of explaining was needed. And, of course, that is exactly what this day is about! So, John and I had a great time.

I decided early Saturday morning to bring the next Carolina EOS balloon payload to the event. I placed it up and out of the way and had it transmit SSTV images of everything going on. I had my FT-897 and my laptop there to receive and decode it. They seemed to think that was pretty interesting. The sound of the SSTV signal really got their attention.

Around 2:30 or 3:00 pm, Kevin (Al4YQ) showed up. He helped us work with the scouts for the remainder of the time that they were there. He also helped us break down everything after they had all left. We finished packing things up at about 5:00 pm. It all seemed to

Riley Hollingsworth Retiring - January 3rd


I was just about to mail this newsletter when I received an email from ARRL stating that Riley Hollingsworth (KZ4DH) is going to retire on January 3rd. Riley has been the FCC Special Counsel for Amateur Radio Enforcement since 1998. This is certainly the biggest news that members of the Amateur Radio Service have heard since the dropping of CW and the accompanying band allocation changes.

Riley has been a very visible figure while heading up the FCC's enforcement efforts. I was not a ham in 1998 when Riley was appointed.

But, apparently, at that time enforcement had been almost nonexistent for about a three year period. We have been very fortunate to have someone in his position who truly loves the Amateur Radio Service. I hope we are so fortunate when the next Special Counsel is appointed.

His love for the service was quite apparent in his "you've got that big knob, use it" speech he gave at Dayton this year. If you haven't read a transcript of it or heard a recording of it, you need to.

VE Test Session - November 17 New ULS Registration Requirement!!!

The Mecklenburg ARRL VE Team will be conducting an exam session for all classes of FCC Amateur Radio License on Saturday November 17th beginning at 9AM at the East Baptist church 3850 Monroe Road Charlotte, NC (East Baptist Church is located next to East Mecklenburg HS, near the intersection of Monroe Rd and Conference Drive)

Applicants are requested to arrive by 8:30AM, to complete the registration process before testing begins. They should bring a photo ID (drivers license OK), the original and a copy of any current amateur license, the original and copies of any current CSCEs, and the 2007-testing fee of \$14.00.

Walk-ins are welcome, but we would appreciate it if you register by sending an email to <u>N4MH</u>. You may call 704-948-7373 if you need additional information.

ULS Requirement

NOTE: the FCC will not process applications for new or upgraded licenses UNTIL the applicant has registered in the FCC's Universal Licensing System (ULS)!

(<u>Hint</u>: If you find that you have an 'FRN number' already printed on the face of your current ham license, you have already registered with the ULS!)

Extract from: Instructions for NCVEC Quick-Form 605 Application for Amateur Operator/Primary Station License http://www.arrl.org/arrlvec/605ins.html

Supplying this form to a Volunteer Examiner (VE), Volunteer Examiner Team or to a Volunteer Examiner Coordinator (VEC) - When using this form, you are required to provide your Taxpayer ID Number (TIN)--which is your Social Security Number (SSN)--or an FCC-assigned Federal Registration Number (10 digits beginning with a "0") on this application. Federal Registration Numbers are assigned by the FCC's ULS Registration system as soon as you are registered in the ULS. If you register electronically, you can immediately view on line your Federal Registration Number. If you register by mail (see below), once FCC processes your registration you can then phone FCC and obtain your FCC-assigned Federal Registration Number. Once you have it, you may use your FCC-assigned Federal Registration Number in place of your SSN for all future Amateur license applications.

Applicants who have not yet registered in ULS or Foreign applicants - may still sit for and take examinations for a new Amateur license, or to upgrade an existing Amateur license with the understanding that <u>no action will be taken by FCC on any application until after the applicant has registered in the ULS</u>. Not being registered in the ULS will cause a delay in the filing of the application. Failure to notify the coordinating VEC of subsequent registration in the ULS, or failure to register, will result in the application being placed *on hold* until this FCC requirement has been met. Foreign applicants (not eligible for a US Social Security Number)

must register on-line as exempt by selecting the reason "the individual is foreign" and a Federal Registration Number will be issued.

Registering in ULS - can be accomplished electronically via the FCC web at http://wireless.fcc.gov/uls/ or by obtaining, completing and forwarding the FCC's ULS Registration form (FCC Form 606) to the FCC by fax (717-338-2693) or by mail to: FCC, 1270 Fairfield Rd, Gettysburg PA 17325-7245. FCC Form 606 can be obtained via the FCC web at http://www.fcc.gov/formpage.html or via FTP at ftp.fcc.gov/pub/Forms/Form606/, or by fax at 202-418-0177 (request Form 000606). The FCC Forms Distribution Center will accept orders by calling 800-418-3676.
